# PENSION DIFFERENTIALS' ADVISORY

## TO OUR DEAR COMRADES AND DEPENDENTS:

Due to the numerous queries on the payment of pension differentials to retirees, please refer to the table below:

All pensioners who are in the initial list of **39,783** recipients but not yet included in the **10,445** payees indicated above will be paid on the succeeding batches depending on the completion of COA validation.

Thus, a pensioner who retired in 2008 will be entitled to receive his pension differential in the 3<sup>rd</sup> Tranche covering CY 2011 rate.

Meanwhile, Finance Service is only responsible on the payment of pension differentials subject to the availability of funds. The determination of list of payees is within the functions of PRBS; hence, any queries pertaining thereto should be addressed to PRBS.
